Returned Checks: There is a \$35.00 charge for all returned checks. If your check does not clear you are ineligible for the cash discount. Your credit card accordingly, and will include the late fee (\$25) and returned check fee (\$35). If we receive two returned checks within one year your tuition payments to automatically run on your credit card between the 1 <sup>st</sup> and 3 <sup>rd</sup> of each month.	
<u>Discounts:</u> (1) There is a 10% discount on tuition of 2 or more children attending El Rancho School full-time (daily, including morning, afternoon, and ext and living together in the same household. The discount only applies when tuition is paid in advance, as to the payment terms of this agreement. The forfeited on any month the payment is received late. (2) A 4% discount is offered for prepayment for the entire regular, academic elementary school year limited to five students on a 1 <sup>st</sup> come, 1 <sup>st</sup> served basis, and is due no later than July 1, 2018.
